#### Updates from October's Board Meeting

The Board of Directors approved the following items at the October 15, 2008 Board meeting:

- Minutes from the May 21, 2008 Board of Directors Meeting
- Financials for May, June, July, and August and September 2008
- Approval of the 2009 Budget with no increase for Lá Solana except for dues for the master association of 6%. SCG has proposed a 4% to 6% increase, which the Board has not yet approved. If the full increase is not approved, then it will create excess funds that can be applied to our operating budget.
- Authorizing management to continue with 4-week CDARS at a rate of 2.37%
- By a 4-1 vote the Board approved to discontinue the purchase of cookies for the clubhouse. Elaine Hall cast a "No" vote.
- Approval of granite in the retention basin behind Building #7
- Approved the expenditure of 6 new banners for the front entrance of the complex from DeSigns Incorporated at a cost of \$1,345.38
- Approval of All City Towing contract for removal of illegal parked vehicles
- Approval to amend the following changes to the Reserve Study: a) a one time expenditure for the retention area; b) update the date when the movie system was replaced; c) add \$5,000 for the repairs of the compactor

The Board also agreed to continue the Newsletter to go out quarterly. The newsletter will be placed on the website and only mailed to owners upon request. Copies of the newsletter will be available in the clubhouse.

#### A Need To Know — Parking Your Car

It was noted at the meeting that we are having some problems with rodents chewing on vehicle wiring. The reason rodents are attracted to and chewing on your engine wires is because automobile manufacturers have discovered another way to save money. Not only do soy products taste good, but it's cheaper than traditional plastic. That's right! Many auto manufacturers are making the covering for engine wires from soy based products and mice and other rodents love the smell and taste of soy.

A big "thank you" goes to Mary Iglehart, Unit #2109 for all of the research she has done on the subject. During her research, Mary discovered several websites that address this issue. Just type in "rodents love to eat engine wires" and you will find several links to reference. Following are some suggestions in dealing with this problem:

- "Mothballs" Tied up in small packages and placed under hood.
- "Mice Kill" These pellets have to be placed in a small container (like a jar top) and placed under hood. They can be purchased at Safeway for \$1.99 (for small box); add some double stick tape to secure container.
- "Liquid Fence" Cost \$11.98 at Home Depot. It is a "Ready for Use Deer and Rabbit Repellent" environmentally safe. We do want to stress that pellets should NOT be placed anywhere but under the hood. They could prove to be deadly to our dogs and cats.

This topic was addressed at the recent Board of Directors meeting on October 15<sup>th</sup>. It was determined that the association is not responsible for the cost of the damage to residents' vehicles or solution to the problem. It was suggested that residents contact their car manufacturer to deal with the problem or research the internet for other solutions.
