Notes From the Board February 12, 2013

We experienced a marathon meeting as much discussion occurred and the agenda was a lengthy one. "My "fanny" was numb by the time we adjourned.

Harry Graham, from our landscape company, opened our meeting with an update on their work. He explained the treatment schedules for the turf, granite and flowers on our property and he discussed the process to eradicate the weeds areas.

Ken Marks presented the financials for Dec.31/12 and Jan. 3/13. Both were approved.

We owe a huge thank you to Barbara Magnusson and Earl Lindquist for their service as the LáSolana's Neighborhood Rep. at the Sun City Grand reps meetings held the first Friday each month. Both representatives have submitted their resignations and your community needs one or two people to fill the void. This is your opportunity to help LáSolana. Earl has graciously agreed to remain until a volunteer comes forward.

Jack Mumford was appointed to the Communications Committee as Earl Lindquist has stepped down. Thank you Earl for your involvement and we look forward to your continuing to write the "meet your neighbor" column in our newsletters.

Patricia Wagner and Suzanne Radi were appointed to the Architectural Review Committee. Trish Carter-Diers, Annette Bergen and Barbara Magnusson had indicated their desire to resign from this Committee. They have served your community well for several years and have done an excellent job. Russ Anderson graciously served as the Board liaison to this committee. A big thank you to all former committee members. The new Board liaison will be appointed in March.

Mike Donovan discussed the various options for bulb replacements for our flood lights. The Board agreed to have the floods replaced to CFL lights as needed.

The Board passed the Communications Committee's Mission statement for the LáSolana website and we are looking forward to a new user friendly product by April 15.

Now that the proximity card access system is up and running, several clarifications of policy were required. The metal security door in the bathroom hallway will be closed by staff at 4:30 pm; coffee will be available in the clubhouse when the staff is on site; and a "learning curve" information document for circulation to residents was approved by a vote of 3-2. Russ Anderson read a statement describing the time lines involved in providing our residents access to the clubhouse.

The Board approved the purchase of 20 folding chairs as requested by the Social Committee at a cost of \$14.99 plus tax.

Ken Marks will be giving the RDA company updated figures for 2012 expenditures and upcoming costs. A motion was approved for \$940 for this work.

I shared with the residents that I was thrilled to sign the Health Easement Agreement on their behalf and that the Board was pleased with the final result. We believe Sun Health will start construction of the wall along the "new" fence line soon.

The Board started the review of a consultant's bid for replacement of the irrigation system. Much more information needs be considered before any action is taken.

Ken Marks discussed the elevator modernization bid and the financial implications as it relates to our reserve study. By moving one building forward to 2013 from the 2017 projected date in the reserve study, there will be an accelerated contribution required in 2014 from the owners. Many ideas were presented and will be considered before voting on this item in March.

I have some closing remarks to make. On behalf of the Board, a big thank you is owed to everyone at LaSolana for their support and partnership over the past 3 years. It takes numerous volunteers to create the wonderful community in which we live. You are so appreciated. JoAnne, Mike and Cindy are exceptional and it has been a pleasure working closely with that team. Thank goodness for Brad, our community manager, who has been such a valuable resource for the Board and especially in my work, as President. You are a great manager and a vital part of LáSolana's success.

"The Board Team": Russ, you have made a difference by spearheading the Chat with the Board" and facilitating the clubhouse open on weekends volunteer list. You continue to provide excellent service as our "Neighborhood Watch" rep. Duey, you have invested many hours on several projects. I commend you for your efforts with Bolt Security in finalizing the quotes and installation negotiations with Brian for our clubhouse access system. Your business and IT expertise will serve this community well. Marcia, it has been a pleasure working closely with you on many issues. Mike's Corner

Prior to vacating your condominium for any length of time, we recommend the following:

- 1. Set the thermostat to 85/90 degrees and leave A/C on.
- 2. Shut off water valves inside closet (1/4 turn crosswise to pipe is off).
- Shut off hot water electric in panel at breaker box.
- 4. Place 2-3 gallon bucket of water in each room.
- Empty ice from bin and lift arm up on ice maker.
- Close all windows, blinds and drapes.
- 7. Make sure that all appliances, etc. are unplugged.
- 8. Remove disposable food from refrigerator and freezer
- 9. Leave a bowl of baking soda in refrigerator and freezer.
- 10. Place saran wrap over toilet seat to prevent water from evaporating.
- 11. Leave an emergency contact phone number and address with the office.
- 12. Make arrangements (if possible) with a friend or relative to occasionally check on your unit monthly.
- 13. Birds nest May/June. Please remove any nests from patio, as needed.
- 14. Bring inside any decorations, mats or tables in front door entrance.
- 15. Remove bikes from bike rack and store in unit.




Meet Your Neighbors
