If you weren't here during the holidays, the Clubhouse & grounds were extraordinarily beautiful thanks to our staff & residents playing Christmas elves! Now we have a sparkling new year with yet another "season" upon us -- what gifts! If you're new, WELCOME to our wonderful LáSolana community. Returning? We're glad to have you back!

For "newbies" to condominium living, the following are important idiosyncrasies to be mindful of: 1) patios & the area outside your front door are limited common areas so there are guidelines for decorations, 2) nothing but the usual household trash goes in our compactor, 3) for owners, all renovations **must** be registered with the office staff before they are begun & your contractor is responsible for removal of any construction materials. Condo documents are extremely important, but not that fun to read, so there are 1-page handouts highlighting the most important points available in the clubhouse office. Our staff is a wealth of helpful information, too!

Harry Graham, our CareScape representative, is available for questions from owners at each Board of Directors' meeting. This past year, we've taken down the trees that posed a danger & removed the turf from damaging the stucco of our buildings. At our November meeting, he recommended that our next priority be the updating of our three irrigation systems, parts of which have reached the projected end of their life. Lush flowering plants are definitely everyone's goal, new plantings will not thrive without adequate/appropriate hydration. While keeping within our Budget, CareScape has been an impressive partner in our uphill battle against the unfortunate damage done by the previous landscaping companies.

Harry & Brad, our City Property manager, addressed the air quality issue resulting from the blowing done by CareScape's employees. Reality is that using a vacuum system would double the clean-up time &, therefore, be a major cost to the Association. They could rake instead of blowing but it would not have the same clean look. Not what any of us wanted to hear but.....

The good news is that three new beautiful Palo Verde trees have been strategically planted on our side of the Colonnade wall. As they grow they will provide a buffer to residents in Building 5 from the lights on their new construction. Also, the turf removed will result in a 30% decrease in our watering costs of that area!

The Board voted to add two new pool lounges. When the lounges were being evaluated, it was noticed that one of our existing pool lounge cushions has a cigarette burn on it & "silhouettes" are visible. Be aware that there are consequences to not using the pool's Smoking Area & please put your towel down when laying on a lounge, especially when you're wearing sunscreen oils.

Lastly, the Board voted to postpone the painting of the Clubhouse until 2016 when the carpeting is scheduled for replacement. This gives us a chance to think about future use of the Clubhouse now that we have evening & weekend access. In the Reserve for Replacement Study, our furniture is projected to last until 2024 but some pieces didn't get that memo! Part of the planning needed is to update our color scheme with the help of a computer-generated program offered by the paint company with which we will be contracting. We are putting together a planning committee so if you're interested in serving, please let the office staff know.


# **Neighbor Representative**
