Among the most recent arrivals with these attributes is **Peter Harry Brown**, a best selling author, who purchased a unit in Building 5. Peter, whose wife of more than 40 years died in November of 2013, realized that a Vista model design owned by his friends Pat and Jack Hitchcock was all that he needed for himself and Zeus, a spirited Jack Russell Terrier. Taking occupancy of his condo on July 30th, he is eager to meet his LáSolana neighbors and take advantage of LáSolana's amenities as well as those of Sun City Grand.



Recently, Peter enjoyed an evening at SCG's Drama Club presentation of the "Plaza Suite." So, theater coupled with his interest in music, he will want to order tickets for SCG's Drama Club productions and the Music Club's holiday performance before it's sold out. Already, Peter has become a member of SCG's Adobe Spa's "Active Aging" program. His participation is a commitment of about two hours daily to strength exercises using all the equipment Adobe offers to achieve that end. Peter has also joined and bonded with a grief support group that meets once a week in SCG for residents who have lost spouses. His wife, Pamela, as well as five of her siblings have died of a virulent form of diabetes. Motivated by his love for her and family, Peter may someday research and write about this disease. Having been an investigative reporter for 30 years with Gannett Newspapers and the Los Angeles Times, he has the skills to accomplish such a goal. In addition, he has also found time over his working years to author several books while he and his wife enjoyed theater and music productions away from her work as a cancer researcher.

Peter was born in Texas to parents who were members of the military. His mother was a WAC and his father was an Army Officer. However, he was raised in Phoenix and is a graduate of the University of Arizona where he majored in History and Photo Journalism. After serving two years in the U.S. Air Force and later the Air Force Reserves, he joined the Yuma Daily Sun as a reporter. Upon joining Gannett and becoming an investigative reporter he served newspapers in San Diego, Santa Fe, Miami, and Dallas where he was a major crime reporter for three years.

Possessing a desire to cover notables in Hollywood, he quit Gannett and started writing for the "Los Angeles Time's Magazine" where he remained for 18 of his 30 years in publishing. Articles he wrote also appeared in Washington Post's "Vanity Fair" and "Parade Magazine." His first book, The Real Oscar was published in 1981. Among his best selling efforts are Marilyn: the Last Take which covers the last fourteen weeks of Marilyn Monroe's life and was widely received in Britain, France, Germany, Japan, and Korea. Another best seller was Howard Hughes: the Untold Story, a biography published in 1997. Kim Novak, the Gabor sisters, and Elvis Presley are also subjects of his books among others. It's not surprising that over the years he has been the recipient of many awards for his research and writing. #### Alert-IRS Phone Scam

A number of our residents have reported being contacted by phone by IRS scammers. Below is an excerpt from the IRS Website

Tax scams take many different forms. Recently, the most common scams are phone calls and emails from thieves who pretend to be from the IRS. They use the IRS name, logo or a fake website to try to steal your money. They may try to steal your identity too. Here are several tips from the IRS to help you avoid being a victim of these tax scams:

#### The real IRS will not:

- Initiate contact with you by phone, email, text or social media to ask for your personal or financial information.
- Call you and demand immediate payment. The IRS will not call about taxes you owe without first mailing you a bill.
- Require that you pay your taxes a certain way. For example, telling you to pay with a prepaid debit card.
